04. First-aid measures

General

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

After inhalation

Remove to fresh air, keep patient warm and at rest. If breathing is irregular or stopped, administer artificial respiration. Give nothing by mouth. Unconsciousness: lateral position - call a physician.

After skin contact

Remove contaminated clothing. Wash skin thoroughly with soap and water or use recognised skin cleanser. Do NOT use solvents or thinners.

After eye contact

Remove contact lenses, irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart and seek medical advice.

After ingestion

If accidentally swallowed obtain immediate medical attention. Keep at rest. Do not induce vomiting.

05. Fire-fighting measures

06. Accidental release measures

Personal precautions

Avoid breathing vapours. Refer to protective measures listed in sections 7 and 8.

Environmental precautions

Do not empty into drains. If the product contaminates lakes, rivers or sewages, inform appropriate authorities in accordance with local regulations.

Methods for cleaning up/collecting

07. Handling and storage

Information for safe handling

Isolate from sources of heat, sparks and open flame. Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates and spray mist arising from the application of this preparation. Avoid inhalation of dust from sanding.

Smoking, eating and drinking should be prohibited in application area.

Storage in accordance with CPR 15-1 or CPR 15-2. Observe label precautions. Store between 0 and 35 degrees C. in a dry, well ventilated place away from sources of heat and direct sunlight.

Keep away from oxidizing agents, from strongly alkaline and strongly acid materials. No smoking. Prevent unauthorized access.

Containers which are opened must be carefully resealed and kept upright to prevent leakage. Do not allow to enter drains.
