## 04. First-aid measures

### General

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

### After inhalation

## 05. **Fire-fighting measures**

### **Suitable extinguishing media**

Alcohol resistant foam, CO<sub>2</sub>, powders, water spray.

### **Unsuitable extinguishing media**

Waterjet.

### **Special risk posed by the substance or by the actual preparation, its combustion products or gases discharged**

Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard.

### **Special protective equipment**

## 06. **Accidental release measures**

### **Personal precautions**

Avoid breathing vapours. Refer to protective measures listed in sections 7 and 8.

### **Environmental precautions**

### **Methods for cleaning up/collecting**

## 07. **Handling and storage**

### **Information for safe handling**

Keep the container tightly closed. Isolate from sources of heat, sparks and open flame. No sparking tools should be used. Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates and spray mist arising from the application of this preparation. Avoid inhalation of dust from sanding.

Smoking, eating and drinking should be prohibited in application area.

For personal protection see Section 8.

Never use pressure to empty: container is not a pressure vessel.

Always keep in containers of same material as the original one.

Comply with the health and safety at work laws.

### **Further information about storage conditions**

Storage in accordance with CPR 15-1 or CPR 15-2. Observe label precautions. Store between 0 and 35 degrees C. in a dry, well ventilated place away from sources of heat and direct sunlight.

Keep away from oxidizing agents, from strongly alkaline and strongly acid materials. No smoking. Prevent unauthorized access.
